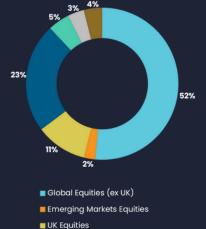

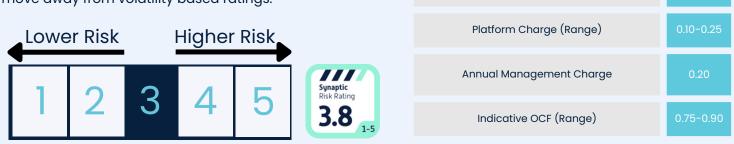
## **Risk Profile:**
